I. Call to Order and Consideration of the Agenda

II. Reports of Officers

- A. President (Bill Fowler): Besides conducting the election, February 23rd meeting will have brief presentations by Lorena Gonzalez-Fletcher on an election update and James McCord to speak on SB 47, the Petition Disclose Act. Mike Bullock will introduce Assemblymember Gonzalez-Fletcher. Bob Spencer commented that Mike Levin may attend.
- B. 1st Vice President (Joan Bullock): An additional pot of coffee will be provided at the February 23rd meeting.
- C. 2nd Vice President (Mike Bullock): Attending events and meetings with public officials toward getting California Democratic Party platform (climate-transportation) into law. Discussing climate action plans with Carlsbad and Oceanside City Councilmembers.
- D. Treasurer (Mary Meyers): Larry Kornit returned the \$1,000 donation given to his campaign by DEMCCO. Mary Meyers will refund \$75 of prepaid dues to Chuck Lowery. The 2019 Budget needs to be approved at the March 23, 2019 meeting. The proposed Budget will be put on the website and the membership will be notified by an announcement in next week's newsletter.

- C. Membership (Shirley Anderson):

- 1. Currently, we have 181 paid DEMCCO members with 353 names on the membership list going back 3 years.

- 3. Last month the E Board discussed allowing special interest groups to promote a local issue at our booths. It was agreed to allow the "Citizens for a Friendly Airport" to participate at the May 5th Carlsbad Village Fair booth. A motion and vote are needed to set a standard for other groups wanting to participate with DEMCCO.
- 4. The DEMCCO Facebook page now has 569 followers. Adding more colorful pictures is being done to improve the appearance of the posts.
- D. Fundraising (Sheila Kadah): The Holiday Party Fundraiser was very successful. Additional opportunities for fundraising should include special speakers such as Adam Schiff.
- E. Political Action (Jason Rosenberg):
 - 1. A free account with MobilizeAmerica is now available.
 - 2. Daron Joffe, an organic farmer, will speak on food justice at the PAC meeting at 9:00 a.m. on February 23.
 - 3. Tasha Boerner Horvath has introduced AB 467 the Equal Pay for Equal Play bill. This bill is designed to address longstanding gender pay gaps in professional sports competitions by requiring equal pay for male and female athletes who participate in competition on public land.
