

DEMCCO General Meeting Minutes

July 23, 2022

The Zoom meeting was called to order by President Linda Slater at 10:14 am with a total of 60 participants: 26 in person and 34 on zoom. She welcomed everyone.

Ann Crosbie made an announcement about a Fundraiser picnic at a local park, most likely on a Saturday morning (10am – noon) in late August or early September. Tickets would be around \$10. Approximately 50% of those present indicated with a show of hands that they would likely attend, and no one opposed the idea.

- I. A motion was made and seconded to modify the agenda by moving the consideration of endorsements up before the program. Yes votes – 13; No votes – 23; Motion failed
- II. Minutes of the May 28, 2022 meeting - not presented

III. Program: Homelessness – Current Research, Practicable Applications, and Solutions

Dr. David A. Snow, Distinguished Professor of Sociology UCI discussed the causes of homelessness, who the homeless are, the challenges of living on the streets, and the costs of homelessness to society. His presentation highlighted the intersectionality between structural antecedents of limited or inaccessible housing and personal, biographic factors which accentuate vulnerability. His research shows that homelessness is a situation in which some people find themselves rather than a particular characteristic of the person so situated. The primary cause of homelessness for both men and women is the gap between the cost and availability of rental housing and the wages/incomes to access that housing. The cost of homelessness and the problematic issues associated with homelessness decrease significantly with the provision of housing, and the results are even more dramatic for the chronically homeless. For example, costs for services for those who are chronically homeless are 50% lower per person when people are housed (\$51,587/year including housing costs) versus when living on the streets (\$100,759/year). When housed, the chronically homeless have 43% fewer visits to the ER, 53% fewer inpatient hospitalizations, 78% fewer ambulance rides, and 100% fewer arrests.

Before Ellen presented, Linda Slater noted that we had not yet given any money to Mike Levin's campaign. **Sheila Kadah made the motion that we donate \$1000 to Mike's re-election campaign for the 49th Congressional District; the motion was seconded and passed unanimously.**

Ellen, deputy campaign manager, stated that Mike's re-election was going to be extremely competitive due to redistricting, dark money pouring millions into negative ads about Mike's record, and malaise among many Democrats. The district is now officially considered a toss up race. The campaign really needs volunteers to knock on doors and could use some help in the office. They have prepared a fact sheet to counter the misinformation in the ads.
