

# DEMCCO General Meeting Minutes

April 22, 2023

The meeting was called to order by President Michele Cyr at 10:28 am with 25 participants in person and 19 participants on zoom for a total attendance of 44. She welcomed everyone and all the new members. Michele provided a Land Acknowledgement.

## I. Approval of Agenda

- Vince Loughney made a motion to remove the Friendly Incumbent Endorsements/New Candidate Endorsements from today's agenda. The motion was seconded. Members were recognized to speak against or in favor of the motion.
- A motion was made by Linda Slater to end debate on the motion. The motion was seconded. Vote to end debate: Yes – 10 in person/12 on zoom; No – 9 in person/none on zoom; **Motion to end debate passed**
- Discussion ended and vote on motion to remove the Endorsements from the agenda was called for a vote. Yes to remove: 4 in person; 1 on zoom; No to not remove: 17 in person; 10 on Zoom; **Motion to remove Endorsements form agenda Failed and Agenda stands**

II. Minutes of the March 25, 2023 meeting were approved as written without objections.

## III. Elected Officials Remarks (2 mins each)

- **Eric Joyce** – Oceanside City Councilmember District 1  
Ban on styrofoam and plastics in Oceanside is being introduced
- **Stuart Gaiber** –Appointed to San Diego County Behavioral Health Advisory Board.  
This Board evaluates the community's behavioral health needs, services, programs, facilities, and procedures used to ensure citizen and professional involvement in the planning process.

Vote to Endorse: All in favor – 23 in person; 12 on zoom

- **Esther Sanchez – Mayor of Oceanside**  
1<sup>st</sup> Democratic mayor to run for re-election  
Barbara Collins moved to approve by Acclamation; Bill Fowler said by unanimous consent

**ENDORSED**

- **Terra Lawson-Reimer – Board of County Supervisors District 3**

Linda Slater spoke representing Terra

Vote to Endorse: All in favor – 18 in person, 11 on zoom

**ENDORSED**

Kathy Rallings made a motion that DEMCCO donate \$500 to each of the candidates the three candidates that received FIE. Motion was seconded. Eric Joyce made a request to move this motion to the next meeting so that it could be on the agenda. Kathy withdrew her motion.

## **B. New Candidate Endorsements**

- **Jaime “Jimmy” Figueroa – Candidate for Oceanside City Council District 3**

Spoke about his background and extensive activism in the community; Born and raised in Oceanside; Priorities will be to bring resources to the underserved community

One person spoke in favor of endorsing; no one spoke against

Vote to endorse – All in favor: 23 in person; 15 on zoom

Mike is excited about a major announcement that will be coming about the interim storage of nuclear waste at San Onofre.
